SUPPLY AND DELIVERY OF 5 PATROL BOTS FOR FISHERY INSPECTION

1. The Government of Mozambique, represented by the Ministry of the Sea, Inland Waters and Fisheries (MIMAIP), received a Credit and a Donation from the International Development Association (IDA), to implement 2 projects namely, **“Sustainable Rural Economy Project (PERS) and Northern Mozambique Rural Resilience Project (MozNorte)”**, and intends to apply part of this funding for eligible payments under the contract resulting from this tender.

2. The Blue Economy Development Fund FP (ProAzul) invites eligible firms with a license compatible with the contracting object, to submit sealed proposals for the supply and delivery of 5 Patrol Boats for Fisheries Inspection as follows:

Lot I - Two Patrol Boats. Nampula(1) and Niassa(1)

Lot II - Three Patrol Boats Maputo(1), Sofala(1) and Zambézia(1)

3. The public tender will be governed by the Regulation for Contracting of Public Works, Supply of Goods and Provision of Services to the State, approved by Decree 5/2016 of 8 March and all bidders from eligible countries may participate in it, as defined in World Bank Procurement Regulation.

4. Interested eligible bidders may obtain additional information from ProAzul – Procurement Department and inspect the bidding documents at the address below from 8:30 Am to 3:00 Pm during normal business days from **September 17, 2021**.

5. All bids must be accompanied by a Bid Security of not less than:

Lot I: 500,000 MZM (five hundred thousand meticals)

Lot II: 700 000.00 MT (seven hundred thousand meticals)

6. Qualification requirements include: (i) certificate issued by a competent authority demonstrating registration in an activity, compatible with the purpose of the contract (ii) presentation of documentary evidence that demonstrates that the bidder executed with good performance at least 2 (two) contracts of a similar nature and of equal or greater value in the last 3 (three) years and (iii) the average annual turnover of the last 3 (three) financial years must be at least:

120 000 000.00MT (one hundred and twenty million meticals) for Lot I; and

190 000 000.00MT (one hundred and ninety million meticals) for Lot II

7. Bidding documents in Portuguese can be obtained by interested bidders upon written request, at the address indicated in paragraph 9, from **September 17, 2021**, upon payment of the non-refundable amount of 1 500(one thousand and five hundred) MZM. Payment must be made by deposit in the MZM account of the Fisheries Development Fund (FFP) No. 6621997101 BCI whose NIB is 000.800000.662.199.710.180.

8. All Bids must be delivered to the address below by 11:00 Am, local time on **October 19, 2021**. Proposals received after this time limit will be rejected and returned unopened. The proposals will be opened in public at 11:15 Am on the same day at the address below and in the presence of the representatives of the bidders who wish to attend the event.

9. The announcement of the positioning of bidders will be made on **November 19, 2021**, at 11:00 am at the address indicated below.
